#### PREPARATION AND SUBMISSION OF TENDER

- 1. The tender should be submitted in Two parts i.e. Prequalification Bid, and Financial Bid by Online Mode Only at Website <a href="https://eproc.cgstate.gov.in/">https://eproc.cgstate.gov.in/</a>Bidder shall also submit a copy of acknowledgment of online submission along with photocopy of pre-qualification documents, DD/Bankers Cheque(EMD) on 13.08.2019before 02:00 PM at the Office of the Medical Superintendent Cum Joint Director, Late Shri Lakhiram Agrawal Memorial Govt. Medical College Asso. Kirodimal Govt. Hospital, Raigarh(C.G)
- 2. Earnest Money Deposit: The bidder shall be required to submit the Earnest Money Deposit (EMD) for an amount of Rupees. 2,00,000 (Rupees Two Lacs Only) by way of Demand Draft/Bankers' Cheque duly pledged in favour of "Medical superintendent Cum Joint Director, Late Shri Lakhiram Agrawal Memorial Govt. Medical College, Asso. Kirodimal Govt. Hospital, Raigarh (C.G.)". The DD/Bankers Cheque for earnest money deposit must be enclosed in the envelope containing the acknowledgment of Online submission and pre-qualification document to submitted in physical form as mentioned above. The EMD of the successful bidder shall be returned after the successful completion of contract order and for unsuccessful bidder(s) it would be returned after finalization of Rate Comparison.

### **INFORMATION & INSTRUCTIONSTO THE BIDDERS**

- 1. Registration of the Bidders on Chhattisgarh Government e-Procurement Portal http://eproc.cgstate.gov.in
  - All the bidders in order to participate in the tenders floated using the Electronic Procurement System are required to be registered on https://eproc.cgstate.gov.in
- 2. Opening of an Electronic Payment account: For Submitting the bids online Bidders are required to make online payment for Bid Submission fee using the electronic payments gateway service as mentioned in the List of online payment modes.
- 3. Payment for submission of bids online: The tender documents may be downloaded online directly by eligible Bidders. The Bidders are required to make the payment for bid submission through online payment modes. The suppliers can submit the bids by making online payment of submission fees using the service of the secure electronic payments gateway, and should print out the system generated receipt for their reference which can be produced whenever required. The secure electronic payments gateway is an online interface between Bidders and credit card / online payment authorization networks. Submission of bids, EMD and other documents will be governed by the time schedule given under "Key Dates" on the online e-Procurement System portal for the particular tender.
- 4. Tender Download: Eligible Bidders can download the Tender Document online.



- Submission of Bid Seal of online bids: The online submission of bids will be 5. preceded by submission of the "digitally signed bid seal" as stated in the tender time schedule (Key Dates) published in the NIT. The contractor cannot change any bid data after the generation of bid seal.
- Opening of Tender documents: The authority receiving the tenders or authorized 6. officer shall first open the "Cover A" of all the bidders and check for the validity of Tender Processing Fee & EMD as required by LSLAMGMC Asso. KGH Raigarh. In case, the requirements are incomplete, the Financial Bid as submitted in Cover B of the concerned bidder received shall not be opened. The authority shall then open the tenders submitted by the suppliers online through the CG Government procurement website.

#### 7. **EARNEST MONEY DEPOSIT (EMD)**

EMD acts as a safeguard against bidder's withdrawing/altering its bid during the bid validityperiod.EMD(or Bid Security) is must for all bidders except for those holding EMD exemption Certificate from the District Industries Centre of Directorate of Industries and Commerce, Govt. of Chhattisgarh. However, the bidder needs to provide sufficient documentary evidence in support of the exemption along with the tender document to avail the same.

#### **Refund of Earnest Money Deposit**

The EMD should be refunded in the following circumstances:

- 1. The EMD submitted by unsuccessful bidders shall be returned after finalization of Rate Contract.
- EMD of submitted by the successful bidder should be returned without any interest after the successful bidder deposits the performance security according to conditions stipulated in the bid document.

#### Forfeiture of Earnest Money Deposit

The EMD shall be forfeited in the following circumstances:

- If the bidder withdraws from the bid in any respect within the period of validity of 1. the bid.
- If any document / information provided by the bidder in support of its eligibility is 2. proved to be false or forged, then EMD may be forfeited.
- If case any bidder withdraws its bids/offer partially (for some item) amount will be 3. forfeited.

Note: Without EMD or Tender fee bidder will not be considered for further process / rejected.

(Except bidder submitted document &eligible for exemption of EMD & tender free)



#### TENDER PROCEDURE

E-tender shall be submitted through Online at Website https://eproc.cgstate.gov.in/in two part, viz., Prequalification bid and financial bid. All the pages of bid being submitted must be signed and sequentially numbered by the bidder irrespective of nature of content of the documents before submitted.

#### 1. Requirements of Cover A: (Prequalification Bid)

The following documents are to be furnished by the bidder along with Prequalification bid as per the tender document: (Annexure –I)

- 1. UTR No. of the Payment of Tender Fees.
- Scanned Copy of EMD must be uploaded. EMD must be in the form of DD/Bankers Cheque of Rs.2,00,000/-(Rupees Two Lacs only) of any scheduled bank in favour of Medical Superintendent cum Joint Director, Late Shri Lakhiram Agrawal Memorial Govt. Medical College, Asso. Kirodimal Govt. Hospital Raigarh (C.G.).
- 3. Bidder must have valid GST registration certificate of Firm/company
- 4. The Bidder should have valid Drug Licence of Firm /Company.
- 5. Bidder should have valid trade licence (Gumasta) issued by Municipal Authorities in case of others/Certification of incorporation in case of company /LIP.
- 6. Bidder should have Average Annual turnover of Rs. 20 Lacs during the last three consecutive years. (Annexure-II)
- 7. The Bidder should have valid PAN of the applicant firm.
- 8. The Firm should submit an Affidavit/Undertaking duly notarized that they have not abandoned, debarred & Blacklisted of any work of State Government etc. during the last five (5)consecutive years
- 9. List of past supplies with performance certificate from end users in Govt./Semi Govt./Public Sector department at least one.
- 10. Affidavit/Undertaking that the firm has no vigilance case/CBI/FEMA case pending against supplier (Principal)
- 11. Affidavit/Undertaking that the firm is not supplying / has not supplied in past two years the same item at the lower rate quoted in the tender to any govt. organization.
- 12. Affidavit/Undertaking for Acceptance of all terms and conditions.



#### II. Required of Cover "B" (Financial Bid)

- 1. Bidder should offer maximum discount on print rate applicable to all Medicines.
- 2. Discount on print rate of highest bidder for Medicines will be negotiable.
- 3. Separate rate for Branded and Generic Drugs as per norms.
- 4. In case of same rate, the firm which is closer to hospital will be prefer.
- 5. The selected firm is bound to supply all the demanded items by the hospital
- 6. Bidder has to quote discount above 52.75% for Generic Drugs and 18.75% for Branded Drugs. If the bidder quotes below the fixed discount structure, bidder will be disqualified.
- 7. In case L1 of Generic Drugs supplier and L1 of Branded Drug supplier both are separate firm, then the Medical Superintendent has the authority to consider the highest discount provider of Branded Drugs to award as L1 bidder.

#### **TERMS & CONDITIONS**

- 1. Dealers/Stockist and supplier from Local Raigarh (C.G.) are eligible to bid.
- 2. Tender document may be downloaded from LSLAMMC Raigarh web site www.gmcraigarh.edu.in(for reference only).
- 3. Bidder must have valid GST Registration and should furnish a copy of GST registration number. Tenders not complying with this condition will be rejected.
- 4. Bidders should have valid Drug Licence of firm
- 5. The MS, LSLAMGMC Asso. KGH Raigarh does not bind itself to accept the lowest or any other tender and reserves to itself the authority to reject any or all the tenders received without assigning any reason. All tenders in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the tender shall be rejected.
- Offer should be quoted in %of Subsidy on printed rate (MRP). No other taxes and duties will be paid over and above the quoted prize.
- 7. The bidder damage during transport/supply of drugs to FOR will be at the cost of bidder. In transit loss up to supply destination has to be borne by the bidder.
- 8. Price should be quoted in Indian Rupees. It should be firm and final F.O.R. to destination and inclusive of all taxes. No other taxes and duties will be paid over and above the quoted price.
- The quoted rates will be valid for 12 months from the date of opening ofPrice Bid.
   Rates once quoted will be final and will not be allowed to be increased during the validity period under any circumstances and for any reason whatsoever.
- 10. Bidder shall make available one person from you, for collection of prescriptions every day at the of fixed by the authority.
- 11. Bidder will receive Prescription every Day (24x7) from Hospital.



- 12. Prescribed Medicine must be made available maximum within 24 Hours in the hospital.
- 13. Bidder should submit monthly bill at the end of month.
- 14. Bidder has to supply only Generic drugs irrespective of name of drugs written on Prescription/Demand Form.
- 15. In situation when Generic Drug is not available then Prescribed Drugs (Branded) can be supplied, but supply of branded drugs should not exceed more than 20% of the monthly billing amount
- 16. If branded drug supply is more than 20% of total monthly billing amount, then penalty will be charged as per below mentioned rate

- 18. Bills for Generic and Branded drugs must be separate.
- 19. EMD of unsuccessfully bidder will be returned from date of finalization of Rate Contract. EMD of successful bidder will remain with buyer till the validity of tender rate.
- 20. Beyond standard consumables kits & reagent should be replace without any conditions.

## OTHER IMPORTANT INSTRUCTIONS

- Price quoted in bid shall be valid for 12 Month from the date of award of quoted item it can be further extended up to 6 months. No change in the price shall be allowed to any reason in the validity period.
- 2. If any articles or things supplied by the bidder have been partially or wholly used after supply and are subsequently found to be in bad order, unsound, inferior in quality or description or otherwise faulty or unfit for usage, then the contract price or prices of such articles or things will be recovered from the bidder, if payment had already been made to him.
- 3. In all the above conditions the decision of the LSLAMGMC Asso. KGH, Raigarh Purchase Committee or any officer authorized by the committee shall be final and binding.
- 4. MS, Lt. Shri Lakhiram Agrawal Memorial Govt. Medical College Asso. Kirodimal Govt. Hospital Raigarh will be the final authority for any changes in tender terms.
